THIS WATERCRAFT RENTAL AGREEMENT CONSTITUTES A CONTRACT BETWEEN RENTER and VOYAGEURS SUNRISE RESORT

1. **WATERCRAFT RENTED:** _____
2. **RENTAL DATE(S):** _____
3. **SECURITY/DAMAGE DEPOSIT:** A credit card is required to be kept on file as a security deposit to rent the subject watercraft. The security deposit will be released after the completion of the rental and inspection period provided no damage to the watercraft is found, and no additional charges have accrued as outlined under this agreement. Voyageurs Sunrise Resort reserves the right to inspect the watercraft up to the time of the following rental term, and to repair any damage that was incurred while RENTER had watercraft in their possession. If damage is caused by RENTER during the rental period, RENTER authorizes Voyageurs Sunrise Resort to charge the credit card on file for the full amount of any such damages, including all repair costs.

This also includes loss of life jackets, PFD's, throwable PFDs, anchors etc. supplied with the watercraft.

4. **FUEL:** RENTER acknowledges that the watercraft is full of fuel at time of rental commencement and is responsible for returning it at the end of the rental period the same.
5. **WATERCRAFT OPERATION:** RENTER acknowledges and agrees that the watercraft will be operated by the RENTER(S) named in this agreement. RENTER warrants that the RENTER is a qualified operator of said watercraft. RENTER (i.e., the person who provides the credit card kept on file) undertakes all financial responsibility regardless of who is operating the watercraft. RENTER will not operate the watercraft, or permit anyone else to operate the watercraft, while under the influence of alcohol or drugs. RENTER will be responsible for the operation of the watercraft within all local, state, and federal laws and regulations. RENTER is solely responsible for obtaining knowledge and understanding regarding all such laws and regulations.
6. **WATERCRAFT USE:** The RENTER understands that conditions (weather, water levels, protruding and submerged natural structures (rock formations etc.) & floating debris etc., are variable, and Renter must exercise caution, pre-planning, and good judgement in the use and operation of the watercraft. At no time shall the total occupancy or passenger and gear weight exceed that specified on the U.S. Coast Guard plate displayed in the watercraft. Even if the weight limit has not been exceeded, caution must be exercised as not to allow waves to enter the boat from rough water etc.
7. **NAVIGATION:** The RENTER shall become familiar with Voyageur National Park official waterway markers in the form of navigational and caution buoys, signs, or lights, either in the water or on shore. Maps and GPS devices are available as well, which identify the waterway markers and pre-designated boating routes.
